# Building Knowledge for Success *Setting the standard for the future*





## Ben Bradford – BB7

### Fire safety's missing link in New Zealand?

Ben Bradford asks: Is fire risk assessment, fire safety's missing link in New Zealand?



An introduction to the UK legislative framework and national guidance on the topic of fire risk assessment. Ben will present the lessons learnt since the introduction of the UK's risk based regime. In NZ most buildings have to have a Building Warrant of Fitness and each year the owner (or representative (IQP) must submit a Form to the Councils to say that their building is still compliant and the maintenance/inspections/testing has been carried out on all specified system. Would the provision of a suitable and sufficient fire risk assessment present a risk reduction opportunity in New Zealand?

### Ben will also be conducting a workshop on day 2 on Fire Risk Assessment.

## Grant McNeil – Kainga Ora

### **Managing the Building compliance and fire evacuation obligations for the largest portfolio in NZ – from the point of view of the owner who is also a qualified IQP.**

Grant McNeil has been involved in the building compliance, fire protection industries for over 25 years, from roles on the tools to senior management as a fire protection contractor, to a sizeable stint as a fire protection and building compliance consultant for New Zealand's largest multi discipline engineering consultancy. Over his time he has authored many fire reports and prepared evacuation schemes for some of New Zealand's most complex buildings, ranging from Parliament to correctional facilities, some employing "defend in place" strategies. Grant is a registered IQP for the majority of active and passive systems and is currently with his team responsible for the Building compliance and fire safety obligations across the Kainga Ora portfolio. Recently Kainga Ora succeeded in having the first lifts for evacuation approved in New Zealand for the use of customers housed that meet the criteria of "persons requiring assistance" in Partnership with the project team and FENZ.

## Garth Moran

### **Compliance for Surface Finishes**

Over the years within New Zealand, there has been little to no clear direction given to the building industry with regards to what is expected from constructors, specifiers, engineers/architects, coating contractors and reviewing engineers/inspectors with regards to passive fire protection, primarily around intumescent coatings. The Fire Protection Association of NZ (FPANZ) has put together a clear and easy to understand Code of Practice for NZ, released in Oct 2020 with an update in November 2022. This is all in aid of lifting the standards of this particular industry sector to where they should be, so NZ doesn't face a "Grenfell," building disaster.

In this talk, I will discuss the most commonly raised questions with regards to intumescent coatings which are covered in the Code of Practice:

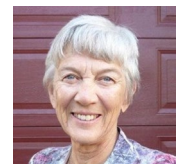
- ▶ Standoff distances between intumescent coated steelwork and timber framing/cladding elements etc and some options on how to correctly design around.
- ▶ What are the allowances for attachments to fire rated members?
- ▶ Distance paint needs to extend along non-fire rated members i.e. coatback distance
- ▶ Tray deck gaps/Trapezoidal Composite Flooring — what is done here?
- ▶ Maintenance and Longevity of intumescent systems, corrosion vs protection of the intumescent
- ▶ Moisture sensitivity — the importance of seal coats, weatherability during construction vs final commissioned state, the right product for the right environment!
- ▶ Inspection methodology and acceptance criteria for intumescent coatings.

## Vivian Naylor

### **People who require Assistance during an evacuation in the event of a fire.**

For over 20 years, Vivian has worked as a Barrier Free Advisor and is contracted to councils, architects, developers, commercial companies, learning institutes and hospitals to review plans from a Universal Design perspective, ensuring a safe and inclusive built environment for all.



She has gained a reputation as a knowledgeable and pragmatic advisor and educator in this field. She was a founding Trustee of the Barrier Free New Zealand Trust and presents workshops around New Zealand on Universal Access and Design.

Vivian currently serves on Auckland Council's Urban Design Panel and is a member of Auckland Transport's Accessibility Groups, giving advice on Auckland's public transport and capital projects. Previous roles have included her membership on the former Department of Building and Housing's Access Advisory Panel. She also served on MBIE's Access Reference Group and Fire Safety reviews.

She presented at the 2009 Fire Protection Conference on Egress for All.

Robert was a member of the committee that prepared the FPANZ Code of Practice for the Integration of Building Fire Safety Systems with other Services.

### Lifts and Escalators - What's behind closed doors and under the covers?

When we all get into a lift and push the button or get on an escalator or travelator we expect it to operate and get us to our destination safely - right?



Lifts, escalator and travelators are one of the very few public transport devices where a dedicated driver is not required. However unlike planes, trains, buses, gondolas, or ferries – if something starts to cause a wobble, or starts being noisy, or no longer operated the way it did yesterday, who is going to realise and report it before it fails? This will be a brief window to some of the common issues found during inspections – and why effective regular preventative maintenance regimes and quality IQP inspection and certification processes need to be implemented and followed

Lyall worked for a multinational lift company for 21 years before leaving to establish Lift Solutions Ltd, an independent specialist lift and escalator consultancy, in 2003. In 2006 he also established Infrastructure Analysis Ltd, a company which undertakes annual IQP inspections and certifications (if they pass), and energy use and performance analysis of lifts and escalators.

With almost 40 years in the industry, Lyall has an intimate understanding of lift standards, service contracts and service delivery requirements, which compliment his technical expertise with both of existing and newly installed equipment.

Lyall is IQP certified throughout NZ for SS8 equipment. He is passionate about raising the standard of lift installation and servicing by working with suppliers to ensure all vertical transport systems remain compliant and safe for users - all of the time.

Lyall joined the Association of Building Compliance management team to further this objective of raising the standard within the industry of building compliance – with incremental improvements being made and realised.

### **Integrated Compliance for Intumescent Coating Systems: A practical approach to compliance for acceptable passive fire solutions.**



With the increasing demand for time & cost saving, sustainable as well as health conscious passive fire solutions in the remediation of buildings, we want to suggest a pathway to compliance for acceptable solutions to upgrade fire-separating elements with intumescent coatings.

With the building code providing only the minimum requirements for compliance we advocate for an approach that goes beyond and offers a holistic interpretation of compliance that is based in system thinking. It incorporates the demands of different stakeholders along the lifetime of a passive fire solution and spans all the way from product manufacturing, over system design and application to the systems compliant maintenance.

We see a standardised, integrated compliance approach as the way forward. It ensures that passive fire compliance is not seen from a single perspective but through a holistic lens within the “system” building.

Shane’s main aspiration is to restore the trust in safe building practices. His commitment lies with the positive contribution to the transformative changes in the Passive Fire Industry in New Zealand.

Compliance for Tech Coatings is based on actual knowledge. An extensive fire-testing regime with CSIRO, BRANZ and most recently with Fire TS Laboratory guarantees that the performance of our products is verified by fire tests.

As the Chair person (member) of Coatings Working Group, appointed by FPANZ, he is leading the team of experts to compile the industry Code of Practice for the specification and application of Intumescent Coatings on structural steel.
